

Join Collier County for a Neighborhood Information Meeting Thursday, August 4, 2022 at 5:30 p.m.

Collier County invites you to a Neighborhood Information Meeting to learn about upcoming construction of the Northeast Service Area (NESA) Utility Extension Project. **The doors will open at 5:30 p.m. and the presentation starts at 6 p.m.** See meeting information on back page. General Project Overview

In 2019, Collier County began a design-build project that is part of the regional water sewer system to meet growing consumer demands throughout the County. The project includes an interim wastewater treatment plant, water storage tanks and associated pipelines. The project areas are divided into five segments (see map on back). Segments 1, 2, and 4 are completed. Segment 3 is on the Northeast Utility Facilities property, located just east of the new Big Corkscrew Island Regional Park and includes underground utilities that service the interim wastewater treatment plant, two pre-stressed concrete water storage tanks and two interim water pump stations (for potable water and irrigation quality water). Upcoming Construction Activities

In August, crews will begin to install potable water, irrigation quality water and wastewater transmission lines within the right-of-way along portions of Everglades Boulevard, 14th and 16th Streets NE, north of the NESA site. The right-of-way, also called ROW, is the part of your property that is used for roads, drainage and utilities. Communications conduits for future utility use will also be installed in these segments.

- **Segment 5A** – begins at 16th Street NE north of the Fairgrounds Canal and extends north to 47th Avenue NE, then west to 14th Street NE, ending just south of the canal.
- **Segment 5B** – includes Everglades Boulevard from 41st Avenue NE north to Immokalee Road.

Crews will start construction activities in Segment 5A first and then continue with Segment 5B. Construction activities will include clearing the ROW along the routes. Pipes will be installed on both sides of the road in Segment 5A and on the west side ROW only in Segment 5B. Crews will install water main pipes, irrigation quality pipes, force main pipes, and two communications conduits for future use. Existing driveway aprons will be removed prior to pipe installation and replaced in-kind after the pipes are installed, tested and approved for service. Fire hydrants will be installed that will allow for better fire protection services.

What to Expect During Construction

Initially, crews will video the area to document existing conditions, then they will clear the ROW. Personal property items such as lighting, irrigation, landscape and decorative mailboxes located in the ROW where work will be performed should be removed or relocated by the property owner. Any personal property items remaining in the ROW once construction starts, will be removed and disposed of by the contractor.

Demolition will include removal of driveway aprons and personal property items within the ROW. United States Postal Service approved mailboxes may be temporarily removed/relocated during construction, but will be reinstalled by the contractor as construction progresses. Once these activities are complete, crews will install potable water, irrigation quality water and wastewater transmission mains from the Northeast Service Area to pipes connecting to the regional system.


Segment Map

Access to Driveways

You may also need to park your vehicle in an area other than your driveway during some construction activities. Our team will notify you when this is necessary. Public Services

The team will coordinate with public services and utilities such as mail delivery, garbage and recycling collection, bus services, and Collier County School Transportation. Sheriff/Fire and Emergency Medical Services (EMS) will be notified of the construction and advised of road closures.
